REGULATION OF THE TEACHERS' COUNCIL OF THAILAND

Regarding Professional Licensure

(Volume No. 2)

B.E.2557 (2014)

Where it is expedient to amend the regulation of the Teachers' Council of Thailand regarding Professional Licensure B.E. 2547 (2004).

By virtue of the provisions of Section 9 (11) (b) (c) (d), Section 45, Section 84 and Section 85 of the Teachers and Educational Personnel Council Act B.E. 2546 (2003), in conjunction with the Teachers' Council of Thailand in Meeting no. 1/2014 on 30 January 2014 and no. 8/2014 on 2 June 2014 with the approval of the Minister of Education, the Teachers' Council of Thailand issues this Regulation as follows:

Clause 1 This Regulation is called the "Regulation of the Teachers' Council of Thailand regarding Professional Licensure (Volume No. 2) B.E.2557 (2014).

Clause 2 This Regulation will become effective on the date of its publication in the Government Gazette.

Clause 3 In this regulation:

"Applicant for License" means an applicant for a teaching license as a foreigner.

"Foreigner" means a person who wishes to become a teacher and does not have Thai nationality.

Clause 4 The provision in paragraph 2, Clause 5 of the Regulation of the Teachers' Council of Thailand regarding Professional Licensure B.E.2547 (2004) shall be cancelled and replaced by the following:

"In case the Applicant for License is a foreigner, he or she shall not have committed any offense under Paragraph I and possess the following qualifications:

1. No younger than 20 years of age
2. Have qualifications no less than that of being a holder of a degree in education or its equivalent or other qualification certified by the Teacher' Council of Thailand (OR)
3. Have a degree in another field and a teaching license from another country or a graduate diploma in education with 1 year of course study (OR)
4. Have a degree in another field and have passed the Teacher's Preparation Examination, including at least 24 units from an educational institution accredited by the Teachers' Council of Thailand, or recognized by accrediting bodies that play a role in higher education, or are approved by the appropriate government authorities in the country of graduation

5. Have continuing experience in teaching of not less than 1 year according to the criteria and procedures as determined by the Teachers' Council of Thailand
6. Have competency in the language used as a medium of instruction as determined by the Teachers' Council of Thailand
7. Have a Thai work permit
8. Have completed training courses as determined by the Teachers' Council of Thailand with the following substance knowledge :
 - (a) Thai language and culture
 - (b) Law relating to professional practice
 - (c) Concepts of education in Thailand
 - (d) Measurement and evaluation in education
 - (e) Psychology of learning"

Transitional Provisions

Clause 5 A Foreigner who has completed an accredited teacher education program in Thailand will qualify for a teaching license without undergoing the training courses as determined by the Teachers' Council of Thailand under the Clause 4, paragraph 2 (8).

Clause 6 A teaching license application submitted prior to the effective date of this regulation shall be processed until completion within 90 days from the effective date of this regulation. Otherwise, the applicant shall comply with all requirements pursuant to this regulation.

Where it is expedient to amend the regulation of the Teachers' Council of Thailand regarding Professional Licensure B.E. 2547 (2004).

By virtue of the provisions of Section 9 (11) (b) (c) (d), Section 45, Section 84 and Section 85 of the Teachers and Educational Personnel Council Act B.E. 2546 (2003), in conjunction with the Teachers' Council of Thailand in Meeting no. 6/2015 on 29 April 2015 with the approval of the Minister of Education, the Teachers' Council of Thailand issues this Regulation as follows:

Clause 1 This Regulation is called the "Regulation of the Teachers' Council of Thailand regarding Professional Licensure (Volume No. 3) B.E. 2558 (2015).

Clause 2 This Regulation will become effective on the date of its publication in the Government Gazette.

Clause 3 The provision of subparagraph (6) of paragraph 2, clause 5 of the Regulation of the Teachers' Council of Thailand regarding Professional Licensure B.E. 2547 (2004) as amended by the Regulation of the Teachers' Council of Thailand Professional Licensure (Volume No. 2) B.E. 2557 (2014) shall be cancelled.

Clause 4 The provision of subparagraph (8) of paragraph 2, clause 5 of the Regulation of the Teachers' Council of Thailand regarding Professional Licensure B.E.2547 (2004) as amended by the Regulation of the Teachers' Council of Thailand regarding Professional Licensure (Volume No. 2) B.E. 2557 (2014) shall be cancelled and replaced by the following:

"(8) Have completed training courses as determined by the Teachers' Council of Thailand"
